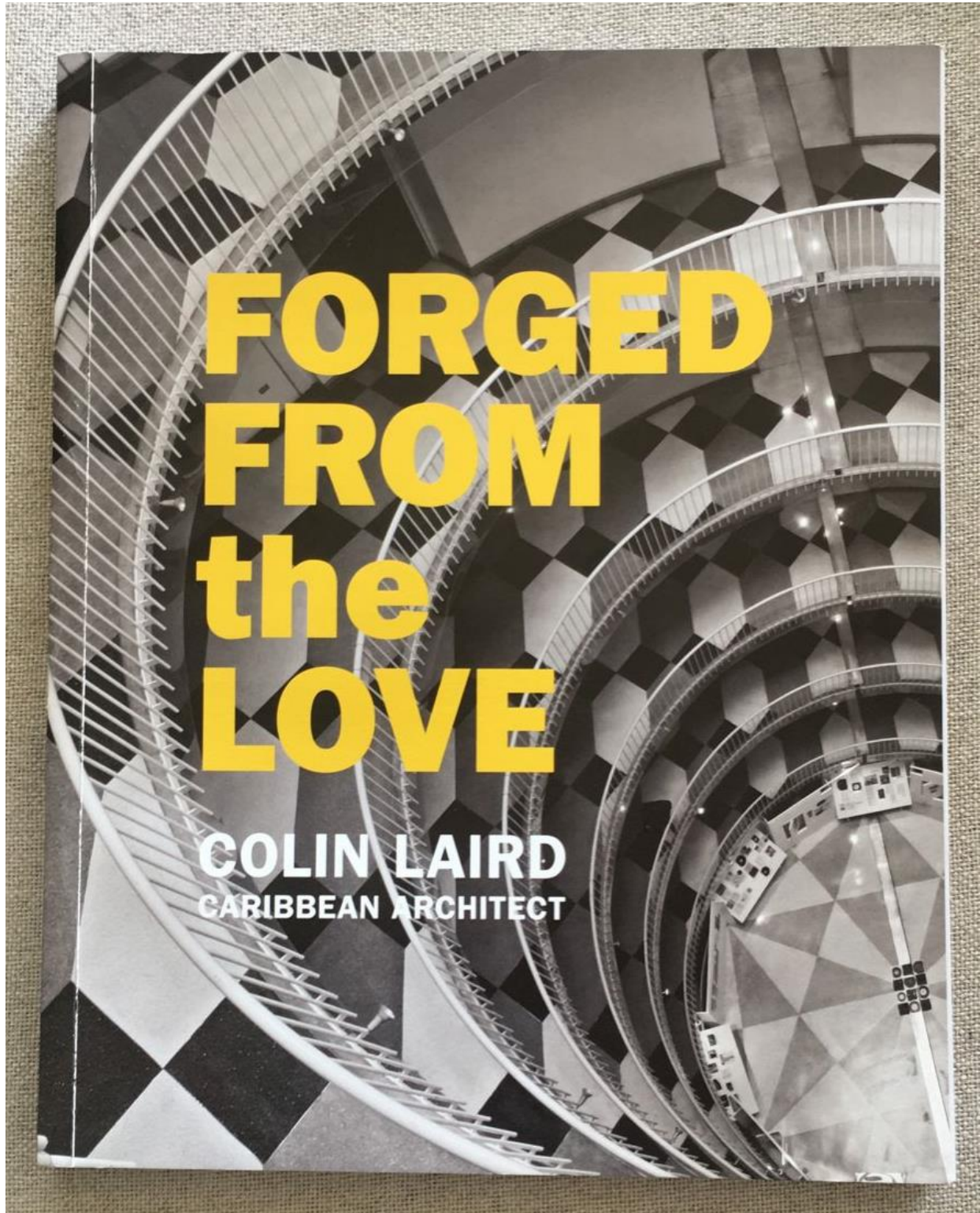

TTIA Colin Laird Grant for Architecture Students

Guidelines





BACKGROUND

The Trinidad and Tobago Institute of Architects (TTIA) is a non-profit organization that promotes the ethical practice, art and science of architecture in Trinidad and Tobago.

Currently, there isn't a school of architecture in Trinidad & Tobago. The grant has been developed to support our nationals of T&T who are studying overseas at accredited architecture programs. The program is free to enter and the objectives are as follows:

- To support our architecture students
- To increase awareness and appreciation of Caribbean Architecture;
- To grow the TTIA, by increasing student membership;
- To foster early involvement of these students into community activities

In order to be eligible, applicants must be:

- Nationals of Trinidad & Tobago
- Currently enrolled in an accredited university studying Architecture
- Student Member of TTIA (no cost)

Successful grant recipients agree to a minimum of one of the following:

- Assistance in the preparation/execution of a TTIA event(s)
- Help to promote the grant
- Present to TTIA membership on a topic that is relevant
- Serve on the grant committee for a minimum of one year
- Facilitate the addition of book(s) on Caribbean Architecture at their school's library



GUIDELINES for SELECTION of Committee

1. Total number of committee members should be an odd number with a minimum of 3, and a maximum of 5 persons.
2. There should be one member of the TTIA executive.
3. There should be one member of the family of Colin Laird.
4. Other members would be made up of TTIA members.
5. There should always be one committee member returning from the previous year.
6. Committee members should not serve more than five years.
7. One committee member would take the lead on managing the grant (with the assistance of the TTIA Administrator).
8. The current lead committee member should handover to the new lead, the year before exiting. And the former lead committee member should stay on to monitor the committee the year after exiting. The current lead committee member would select the new lead committee member.
9. Duties/activities are as follows (but are not limited to) and should be assigned accordingly:
 - a. Kick off meeting – creating agenda
 - b. Creating and executing advertisements
 - c. Management of online application process
 - d. Management of judges and judging
 - e. Management of funds/fundraising efforts/partners
 - f. Liaising with students/recipients
 - g. Coordination with Colin Laird family
 - h. Providing content to TTIA for updating TTIA website/social media platforms with the same
 - i. Continual improvement of program (ultimate goal of becoming a scholarship)



GUIDELINES for GRANT

1. Annually:
 - a. Committee meeting - March
 - b. Advertised in April
 - c. Online Application period 01-31 May
 - d. Judging and notice of award – June
 - e. Award – July or August
 - f. Fundraising December/January/ as needed
2. Established as \$TT 10,000.00 in 2023 (growth encouraged every year)
3. Awarded to a total of 3 students each year, 1 grant per category, see below
4. Financial partners asked to commit to donating a fixed amount (range: TT\$ 5,000.00 or \$TT10,000.00 or \$TT 15,000.00 or \$TT 20,000.00 or more) every year for 3 year period example 2023 to 2025; 2026 to 2028

GUIDELINES for SELECTION of Judges

1. **Committee members for the grant cannot serve as judges.**
2. Total number of judges should be an odd number with a minimum of 3, and a maximum of 5 persons
3. There should be one internationally based judge who is an architect.
4. A majority of the judges should be architects.
5. There must be one representative from the Colin Laird family serving as a judge or an architect recommended by the family.
6. Every effort should be made to have a wide diversity of judges, for example:
 - a. At least one judge should be a female architect.
 - b. At least one judge should be a minority architect.
7. The same judges must review all the applications.
8. One judge would be the head judge responsible for moderating any discussions and tabulating the scores (with the assistance of the TTIA Administrator). The head judge is to be selected by the lead committee member and or by vote amongst the judges.

GUIDELINES for JUDGING

JUDGING CATEGORIES (based on skillsets)

- Category 1 - Masters yr 5-6
- Category 2 - Undergraduate yr 3-4
- Category 3 - Undergraduate yr 1-2

1. Note that all categories do not have to have a winner.
2. If a category has one entry, then judges are not obliged to give that one person but MAY select from another category.
3. See sample of Judging Score Sheet attached.

JUDGING CRITERIA

	Criteria	What to look for	Score
1	Design Portfolio	Creativity, presentation style, technical skill, clarity of intent, sustainability (environmental stewardship and social responsibility)	1- 10
2	Personal Statement (max. 500 words)	Communication skills and Character: integrity, team player, diligent, well rounded	1- 10
3	Reason why you need the grant (max. 500 words)	Financial constraints	1- 10
4	Topical Question (max. 500 words)	Maturity of thought: Intellect, world view, contention to humanity/universe	1- 10

1. Any entry scoring lower than 20 out of 40 is disqualified.
2. Any entry with a portfolio scored **lower than 6 out of 10** is disqualified.
3. If all applicants do not meet the judging criteria, no awards would be made that year. The funding from that year, would be reassigned to future year(s).

Samples - Topical Question:

- What is the role of architecture in society?
- Why is the role of the architect important in society?
- What do you see as the role of the architect in light of the increases in artificial intelligence and global connectivity?
- contemplate on the relationship between the environmental crisis and architecture
